## 10 How we use IP tracking

10.1 We use IP Address tracking technology to identify businesses visiting our site and the pages that are being used. This helps us analyse data about web page traffic in order to develop and improve our website for business visitors.

#### 11 Are there any exceptions?

- 11.1 Techneds Ltd will only disclose your Personal Information, without your consent, if we are:
- 11.2 Required to by law; or
- 11.3 Must do so in support or protecting our own rights, such as to collect monies owed or to seek legal remedies.

- 14.10 The retention periods for the personal data.
- 14.11 The rights available to individuals in respect of the processing.
- 14.12 The right to withdraw consent (if applicable).
- 14.13 The right to lodge a complaint with a supervisory authority.
- 14.14 The source of the personal data (if the personal data is not obtained from the individual it relates to).
- 14.15 The details of whether individuals are under a statutory or contractual obligation to provide the personal data (if applicable, and if the personal data is collected from the individual it relates to).
